



NOMINATION FORM

Induction into the American Home Furnishings Hall of Fame Foundation, Inc., is the industry's highest honor as a lifetime achievement award honoring the full body of their life's work. The process is intensive, conducted over a five-month period by a Selection Committee comprised of seven industry executives who study the careers of leaders across every segment of the industry. According to the Foundation's Bylaws, the Committee has full authority to select three to five individuals, following a careful assessment of a comprehensive body of an individual's innovations, achievements, leadership and philanthropy as documented throughout their careers. Each Committee member votes anonymously and independently online, using a points-base ballot. To maintain full integrity, the entire process remains fully confidential until the names of the inductees are announced publicly in late spring.

NOMINATION PROCESS:

1. Any member of the American Home Furnishings Hall of Fame Foundation may nominate **one** qualified individual. A seconding nomination from another Foundation member is also required.
2. Nominations are made by completing this form in full and submitting it, along with a bio, a resume/business timeline and photograph of the nominee, to the Foundation. Other supporting documentation is welcomed. A points-based rating system will be used to determine and accept qualified nominees. **It is important that the nomination form is filled out completely and thoughtfully, as this information will be used in the scoring process.**
3. An independent selection committee will choose the most qualified candidates.
4. Candidates may be nominated and elected posthumously.
5. Members of the Executive Committee of the Board of Directors or the Selection Committee are not eligible to nominate or second an individual.

CANDIDATE QUALIFICATIONS AND REQUIREMENTS:

A qualified candidate must:

- Do business in the United States
- Have served in the industry for at least 15 years
- Have created a legacy as a positive influence and champion of the industry
- Candidates should have achieved the pinnacle of their careers and directionally trend to be at least 60 years old
- May not have died in the 12 months prior to the date of the nomination.

They should also represent the following standards:

1. **Enduring Excellence** in their personal and business affairs, a person who is considered an inspiration, role model and mentor to others.
2. **Superior Accomplishments** as an enduring and visionary leader in their field, and their organization should exemplify the highest standards for their customers and their employees.
3. **Innovation and Creativity**, a person whose ideas have greatly influenced and impacted the industry and produced changes in design, retailing, merchandising, marketing, manufacturing, importing, supply chain or support services to the industry.
4. **Philanthropic Generosity** of their time, talents and resources to others, whether that may be the industry, professional associations, service enterprises, civic endeavors, charitable and religious organizations, or educational institutions.
